**List of changes from Proposed Submission (January 2012) as at

This document combines all of the changes that have been made from the Proposed Submission document (January 2012) towards a finished Core Strategy Focussed Review, as at March 2012. It lists precisely all of the changes that are proposed to be made, clearly identifying what and where any changes have occurred.

At the Proposed Submission (January 2012) Regulation 27 stage there were 56 representations received from 20 individuals. A full report on all of these representations, including a summary, suggested changes, and Officer recommendations is available from the Mid Suffolk website: www.midsuffolk.gov.uk , entitled "Responses and Recommendations to Proposed Submission (January 2012)".

Overall, the Council believe these to be 'minor changes'. It is felt they, neither individually or collectively, pose what could be classified as a 'significant change'. No new policies or sites are being proposed, and no new approach or methodology is being suggested. These listed changes would be implemented to either improve the format or the emphasis of the document.
